

Grab Your Bags. NELA's Online Services are Moving July 16!

At the 2011 Fall NELA Executive Board Meeting, the Board enthusiastically voted to invest in upgrading and enhancing NELA's online services. The scope of this project includes updating how you collaborate, strategize, and network. Our goal is to reimagine how you share information online. Earlier this year, we partnered with Higher Logic in order to enhance NELA's online services. Higher Logic's Connected Community is the platform for our new, centralized site for all of NELA's online member resources. Our new online community is called "The NELA Exchange" ("The Exchange"). If you are a member of any of the following associations, you may already be familiar with the Connected Community platform.

Beginning July 16, The Exchange will replace our current online Membership Directory and NELANet. Here are just a few features available in The Exchange.

Groups Are Replacing NELANet Forums

The Exchange includes 16 substantive Groups, each with its own listserv and document library. You will be able to subscribe to any Group whenever you like and choose how you wish to participate.

- Real Time Receive and respond to messages as they are posted by clicking on the links in the message and entering your response on The Exchange.
- Daily Digest One daily auto-generated summary of the day's postings.
- Legacy Full participation via Outlook or your email client of choice. (No need to visit The Exchange.)
- No Mail You will not receive messages sent to the Group.

The Executive Board, committees, and task forces will have private Groups on The Exchange to assist them in their work on behalf of NELA.

Getting Started With The Exchange

Login to The Exchange at http://exchange.nela.org. Your user name is your email address. Your password is your last name. We strongly suggest you change your password as soon as possible.

Set up your subscriptions:

Real Time - Receive and respond to messages as they are posted by clicking on the links in the message and entering your response on The Exchange.

Daily Digest - One daily auto-generated summary of the day's postings.

Legacy - Full participation via Outlook or your email client of choice. (No need to visit The Exchange.)

No Mail - You will not receive messages sent to the Group.

Subscribe to the RSS feed to keep up with the NELAHQ Blog. Our RSS feed also allows you to be notified each time something is added to The Exchange.

Update your profile

Add to the library collections. Upload briefs, jury instructions, and other documents you think others will find useful. Don't forget to tag your documents. Tags will make searching easier.

New Libraries Make Sharing Documents Easier

Attachments to list messages will be automatically indexed and added to that Group's library. You will be able to add tags to your attachments and document uploads. Tags allow for quicker sorting when returning search results. When you see a tag, simply click on it to begin searching The Exchange. Documents without tags will still be included in searches, but may end up toward the bottom of the results. If you opt to join a Group and participate via the Legacy option, you will not be able to attach documents to your posts. You will have to visit The Exchange in order to upload, tag, and have your attachments indexed.

Libraries have also been created to organize NELA's *amicus* briefs, *The Employee Advocate* articles, press releases, toolkit papers, reports, member services forms, and more.

Get To Know Your Neighbors

The new online Membership Directory will include your contact information, committee memberships, areas of concentration, and Affiliate membership. Members will also have the opportunity to provide biographical information, professional experience, and more.

If you have a LinkedIn account, you can easily bring over your profile information into The Exchange. You can also link to your Facebook and Twitter accounts. Networks are automatically created to help you connect with other members in your city and state, NELA affiliate, and Group subscriptions. A Primary Company network allows everyone to view a snapshot of NELA members within your firm. Find NELA members near you and update your profile.
